As an essential component of consideration to participate in the activities included in and surrounding the Firearms Course(s), Participant specifically acknowledges and represents to the instructors, all title holders, licensees, and concessionaires of Trigger Happy SLO, LLC. and all members, officers, directors, agents, employees, and instructors, (herein referred to as "Released Parties") that participation in the above-entitled course(s) may be considered hazardous and that the handling and use of firearms may be hazardous and Participant expressly assumes all risk of injury and releases, holds harmless and indemnifies, the Released Parties from and all liabilities, claims, injuries and damages arising out of participation in the course(s), including but not limited to, losses, claims or liabilities caused by the passive or active negligence of the released parties, or defects in the equipment, premises or facilities used. Participant hereby acknowledges, understands and agrees to the following:

Participant fully understands that he/she and other students in the class will have access to and must handle firearms and ammunition as an essential part of the curriculum of the Firearms Course(s). Participant further acknowledges that handling firearms and using firearms can INVOLVE RISK AND DANGERS of serious bodily harm and serious bodily injury, including DEATH. Participant fully understands these risks and dangers may be caused by their own actions, their own inactions, omissions, the actions, or inactions of other participants in the class, the conditions in which the handling of firearms takes place (including but not limited to the firing range and its equipment and

Participant EXPRESSLY, SPECIFICALLY AND VOLUNTARILY ACCEPTS AND ASSUMES ALL RISK OF PROPERTY DAMAGE PERSONAL INJURY OR RISK OF DEATH sustained while participating in FIREARMS COURSE(S), including the risk of passive or active negligence by the Released Parties, or hidden, latent or obvious defects at the Training Site, or in the equipment used.

Participant Agrees and Warrants that he/she will examine and inspect each activity or piece of equipment involved in the Firearms Course(s) (including but not limited to standard firearms, ammunition, holsters, firing range, firing range equipment, hearing protection, eye protection, or any other equipment used in or for the Firearms Course(s)). Participant hereby FULLY ACCEPTS AND ASSUMES ALL RESPONSIBILITY FOR THE RISKS of using any facility or equipment in or for the Firearms Course(s) regardless of the origin or ownership of the equipment. If participant observes any activity or any equipment that he/she considers to be hazardous or potentially harmful to themselves or others, participant will notify the instructor of the Firearms Course(s) immediately and will refuse to take part in any activities they consider unsafe until the condition has been corrected to their satisfaction.

Participant understands the curriculum of the Firearms Course(s) includes sections that cover several topics regarding firearms. However, he/she fully understands that they are solely responsible for when, where and how he/she shall own, possess, carry, or use a firearm and/or weapons.

PARTICIPANT HEREBY VOLUNTARILY AFFIRMS AND AGREES that HE/SHE FULLY WAIVES, RELEASES, INDEMNIFIES, HOLDS HARMLESS and DISCHARGES, "Released Parties" involved in the Firearms Course(s), from any and all liability, claims, demands, actions, rights of action, causes of action, or legal proceeding whatsoever, whether personal to participant or to a third person should they become injured from whatsoever cause (whether physically, financially, or emotionally) or cause injury to others while they are involved in activities during the Firearms Course(s), or coming or going to any activity during the Firearms Course(s).
